The following Walmart Financial Services Consumer Privacy Notice applies to you if you are an individual who resides in the United States and use Walmart financial services primarily for your own personal, family or household purposes.

FACTS	WHAT DOES WALMART DO WITH YOUR PERSONAL INFORMATION?

Why?	Financial companies choose how they share your personal information. Federal law gives consumers the right to limit some but not all sharing. Federal law also requires us to tell you how we collect, share, and protect your personal information. Please read this notice carefully to understand what we do.
What?	<p>The types of personal information we collect and share depend on the product or service you have with us. This information can include:</p> <ul style="list-style-type: none"> Social Security number Transaction history and account transactions Credit scores and checking account information <p>When you are <i>no longer</i> our customer, we continue to share your information as described in this notice.</p>
How?	All financial companies need to share customers’ personal information to run their everyday business. In the section below, we list the reasons financial companies can share their customers’ personal information; the reasons Walmart chooses to share; and whether you can limit this sharing.

Who is providing this notice?	This Notice applies only to check cashing services offered by Walmart Inc.

What we do	
How does Walmart protect my personal information	To protect your personal information from unauthorized access and use, we use security measures that comply with federal law. These measures include computer safeguards and secured files and buildings.
How does Walmart collect my personal information?	<p>We collect your personal information, for example, when you</p> <ul style="list-style-type: none"> • open an account or give us your contact information • provide account information • show your driver’s license or show your government-issued ID <p>We also collect your personal information from others, such as credit bureaus, affiliates, or other companies.</p>
Why can’t I limit all sharing?	<p>Federal law gives you the right to limit only</p> <ul style="list-style-type: none"> • sharing for affiliates’ everyday business purposes – information about your creditworthiness • affiliates from using your information to market to you • sharing for nonaffiliates to market to you <p>State laws and individual companies may give you additional rights to limit sharing. See below for more on your rights under state law.</p>

Definitions	
Affiliates	<p>Companies related by common ownership or control. They can be financial and nonfinancial companies.</p> <ul style="list-style-type: none"> • <i>Our affiliates include companies with and without a Walmart name. Our affiliates include One Finance, Inc. Walmart does not share financial services information with Sam’s Club.</i>
Nonaffiliates	<p>Companies not related by common ownership or control. They can be financial and nonfinancial companies.</p> <ul style="list-style-type: none"> • <i>Walmart does not share with nonaffiliates so they can market to you.</i>
Joint marketing	<p>A formal agreement between nonaffiliated financial companies that together market financial products or services to you.</p> <ul style="list-style-type: none"> • <i>Walmart does not jointly market.</i>

Other important information	
<p>This notice is provided on behalf of affiliates in the Walmart family of companies. We may use your personal information for undertaking activities to verify or maintain the quality or safety of our services or devices and to improve, upgrade, or enhance them, such as training our artificial intelligence tools (“AI”).</p> <p>California and Vermont Residents: Under California and Vermont law, we will not share information we collect about residents of California or Vermont with companies outside of our corporate family other than as</p>
